**TO:** Paul Stone, owner/operator of Canada Photo Safaris, and his/its directors, officers, employees, guides, agents, associates, volunteers, representatives, independent contractors, subcontractors, sponsors, successors and assigns (all of whom are hereinafter collectively referred to as "THE RELEASEES")

**DEFINITION**

In this Agreement, the term "adventure activities" shall include all activities, events or services provided, arranged, organized, conducted, sponsored or authorized by THE RELEASEES and shall include, but is not limited to: wildlife viewing; sight-seeing; hiking; boating; canoeing and kayaking; river rafting; horse-back riding; mountain biking; rock climbing; skiing; heli-skiing; dog-sledding; orientational and instructional courses, seminars and sessions; travel by land, air and water; transport and accommodation; and other such activities, events and services in any way connected with or related to the adventure activities.

**ASSUMPTION OF RISKS**

I am aware that adventure activities involve many risks, dangers and hazards. The risks, dangers and hazards of **adventure activities** include, but are not limited to: changing weather conditions; exposure to temperature extremes or inclement weather; travel or transport to and from the sites used for adventure activities; travel on highways and backcountry roads; encounters with domestic and wild animals and birds including dogs, bears, cougars, wolves, elk, moose, birds of prey and insects; collision with pedestrians, motor vehicles and cyclists; becoming lost or separated from one's party; negligence of other participants; and **NEGLIGENCE ON THE PART OF THE RELEASEES, INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF ADVENTURE ACTIVITIES.** Communication in remote terrain, which is sometimes used for adventure activities, is difficult and in the event of an accident, rescue and medical treatment may not be readily available.

I AM AWARE OF THE RISKS, DANGERS AND HAZARDS ASSOCIATED WITH ADVENTURE ACTIVITIES AND I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, ILLNESS, DEATH, PROPERTY DAMAGE OR LOSS RESULTING THEREFROM.

**RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT**

In consideration of services received by me from or on behalf of THE RELEASEES, and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, I hereby agree as follows:

1. **TO WAIVE ANY AND ALL CLAIMS** that I have or may have in the future against THE RELEASEES and **TO RELEASE THE RELEASEES** from any and all liability for any loss, damage, expense or injury including death that I may suffer or that my next of kin may suffer as a result of my participation in Adventure Activities, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT, R.S.B.C. 1996, c. 337, ON THE PART OF THE RELEASEES, AND INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS, DANGERS AND HAZARDS OF ADVENTURE ACTIVITIES REFERED TO ABOVE;

- TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any property damage or personal injury to any third party resulting from my participation in adventure activities;
- That this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and representatives in the event of my death or incapacity;
- This Agreement and any rights, duties and obligations as between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of British Columbia and no other jurisdiction; and
- Any litigation involving the parties to this Agreement shall be brought solely within the Province of British Columbia and shall be within the exclusive jurisdiction of the Courts of the Province of British Columbia.

In entering into this Agreement I am not relying on any oral or written representations or statements made by THE RELEASEES with respect to the safety of adventure activities, other than what is set forth in this Agreement.

**I CONFIRM THAT I HAVE READ AND UNDERSTAND THIS AGREEMENT PRIOR TO SIGNING IT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES.**

## IMPORTANT NOTICE:

If you purchased trip cancellation insurance, the coverage includes trip interruption and travel delay insurance. Please ensure that your period of coverage includes all of your travel days. Call your insurance company if you need to change your dates of travel and/or add coverage for extra hotel nights, nonrefundable flights or other services.



## TERMS AND CONDITIONS

- All prices quoted in Canadian or US dollars and must be paid in the currency quoted on your invoice.
- Deposits and tour payments may be made by certified cheque or bank draft, wire transfer, Visa, Mastercard or American Express.
- All tours (except *Wildlife of the West Kootenays*) require a 50% (non-refundable) deposit to confirm your reservation.
- Balance is due in full by the first day of your tour. If final payment is not received we reserve the right to treat your reservation as cancelled, as if in writing, as per our cancellation policy below.
- Any cancellation by the client must be received in writing, at which time the following fees apply:
  - 31 or more days prior to first day of tour: 50% of trip fee.
  - 30 days or less: 100% of trip fee.
- The receipt of your deposit, registration information and signed release of liability is a requirement for your seat to be considered booked.
- Reservations will be confirmed in writing upon receipt of registration information and release form, along with the required deposit, and at that time a contract comes into existence between us.
- *Wildlife of the West Kootenays* tours do not require advance booking and can be paid for in full at the start of your tour.
- Canada Photo Safaris reserves the right to change any of the prices, dates, services or other particulars quoted at any time. Should an alteration in the itinerary or a cancellation become necessary, you will have the choice of accepting the change, taking an alternative tour (and where this is of lower price we will refund the difference,) or withdrawing from the contract and accepting a refund of all monies paid thus far to Canada Photo Safaris.
- Cost increases can occur unexpectedly due to rising costs of airfares, ground transportation, fuel surcharges or accommodations, etc.. Canada Photo Safaris may be compelled to amend its prices due to such unforeseeable circumstances. An increase in price shall not be sufficient grounds for any refund, other than as determined by the terms of our cancellation policy.
- No partial refunds are made for unused portions or services of a tour for any reason whatsoever. Tours are sold as a package only. This policy also applies to tour extensions and customized itineraries. Cancellation fees are non-transferable.
- Prices quoted here do not include airfare or other transportation to and from your home to the pick up and drop off locations, airport departure taxes, insurance, alcoholic beverages and bar expenses, tips and gratuities, phone calls, passport or visa expenses, laundry or other items of a personal nature. Gratuities to tour leaders are optional and always appreciated.



## TERMS AND CONDITIONS cont...

- Canada Photo Safaris is not party to any flight bookings you make yourself and has received no payment for the same. We will not refund any cost of your flight in the event of a tour cancellation. For this reason all participants are **strongly** urged to purchase travel protection insurance. The insurance should cover the loss, expenses and damages arising from, including but not limited to, the cancellation of the holiday (whether in whole or in part), personal accident and injury, medical and repatriation costs (for overseas travelers), loss of baggage and personal money and belongings, and flight cancellations and delays.
- Appropriate travel documents for entry into Canada are the responsibility of tour participant. (Currently US travelers require a passport for returning to the US from Canada by **air only**.) Any information or advice given by us regarding visas, vaccinations, climate, clothing, baggage, special equipment etc. is given in good faith.
- Canada Photo Safaris tours are generally considered as soft adventure activities and are well within the capabilities of average people in good health. Certain tours may require the capability to walk for several miles over uneven terrain, stepping from boats onto rocky shores, flying in small planes and occasionally hiking at high elevations. If you have concerns regarding your capabilities and/or fitness regarding your participation in a particular activity or tour, please inquire with our office before reserving a seat.
- Canada Photo Safaris reserves the right to request a doctor's statement of good health. The tour leader's judgment will provide the ultimate determination of an individual's ability to embark on or continue on an activity. Once a tour has been confirmed, medical circumstances will not be considered as exceptions to our cancellation policy. We assume no responsibility for medical care or special dietary requirements.

**By signing a registration form and paying your tour deposit, you certify that you do not knowingly have any physical or other conditions of disability that would create a risk for you or other tour participants.**

- Pre-departure information will be supplied upon registration describing the specific costs that are included in your tour fee. Generally these costs include lodging in double room occupancy hotels, cabins or chalets, all meals, ground transportation during the tour and guide services.
- The nature of our tours requires flexibility to allow for changes in weather, animal behaviour, natural history or cultural events or other logistical arrangements deemed necessary by Canada Photo Safaris or its leaders. For this reason the itineraries and tour descriptions outlined must be taken as a guide to what may take place on any given day, and not as a contractual obligation.
- It is the responsibility of the tour participant to immediately communicate any perceived failure in the performance of this contract to the tour leader thus giving the tour leader the opportunity to achieve a satisfactory solution.





## TERMS AND CONDITIONS cont...

- Canada Photo Safaris and/or its agents act only for the tour participant in regard to travel including, but not limited to, sightseeing, meals, lodging, transportation and all other services whether by railroad, motorcar, motor coach, boat, ship, ferry or aircraft and they assume no liability for additional expense, injury, damage, loss, accident, delay or irregularity which may be occasioned either by reason of defect in any vehicle or for any reason whatsoever, or through the acts or default of any company or person engaged in conveying the passenger or in carrying out the arrangements of the tour.
- Canada Photo Safaris reserves the right to 1) substitute hotels of similar category for those indicated and to make any changes to the itinerary or transport where deemed necessary or caused by changes in air schedules or equipment substitution; 2) cancel any tour prior to departure, in which case full refund of all moneys paid for the tour will be given, but Canada Photo Safaris is not responsible for any other trip preparation expenses such as penalized or non-refundable air tickets, visa fees and medical related expenses; 3) substitute tour leader(s) for the leader(s) originally specified, in which case the substitution is not a basis for participant cancellation or refund other than provided by our normal cancellation policy; 4) accept, retain or refuse any person as a member of any tour.
- Canada Photo Safaris accepts no responsibility for losses or additional expenses due to changes in air or other services, sickness, food-related illness, quarantine, theft, accidents, adverse weather conditions, fire, flood, other forces of nature, strike, war or the threat of war, riots, terrorist activity, civil strife, political instability, government restrictions or regulations change, industrial disputes, natural or nuclear disasters, or other causes. All such losses or expenses will have to be borne by the passenger, as tour fees provide for arrangements only for the times and locations stated. Baggage is at the owner's risk entirely.

**A Release and Assumption of Risk form must be signed by each participant prior to the commencement of the tour. Participation by any tour member will be declined in the absence of the signed release of liability form, with no tour fee refund. No modification to the terms of the Release and Assumption of Risk form will be accepted.**

- Should Canada Photo Safaris or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, the enrolling tour participant(s) agree(s) to indemnify and hold them harmless for all such fees and costs. In the event a lawsuit is filed, the enrolling participant(s) agree(s) to do so solely in the province of British Columbia, Canada.
- Certain operators and suppliers require their own release and liability waiver forms to be signed, in addition to that already signed on behalf of Canada Photo Safaris, in order to limit that operator's or supplier's liability. The tour participant is bound by the terms of these waivers of liability with respect to the participant's relationship to the operators or suppliers, their agents (Canada Photo Safaris) and their employees and volunteers.
